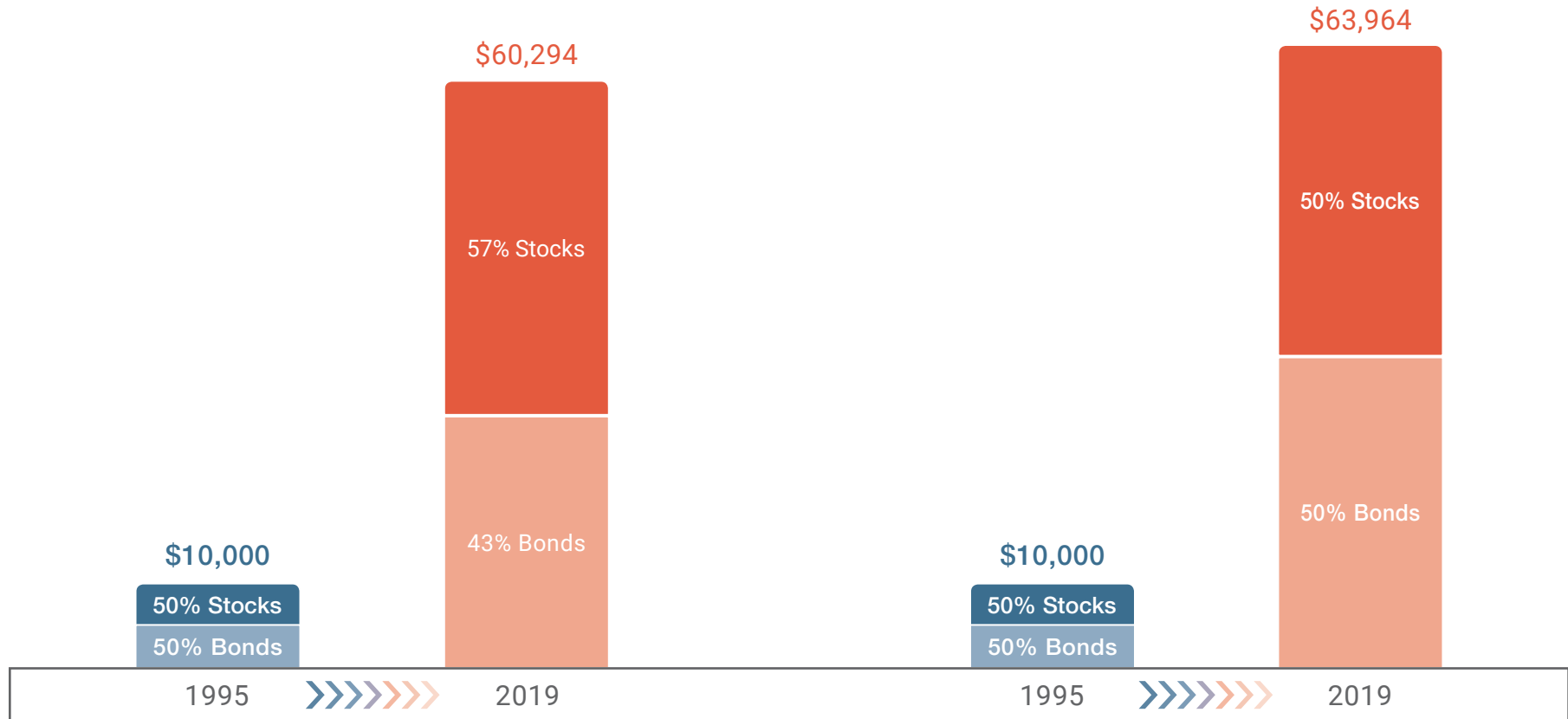


Rebalancing Act
