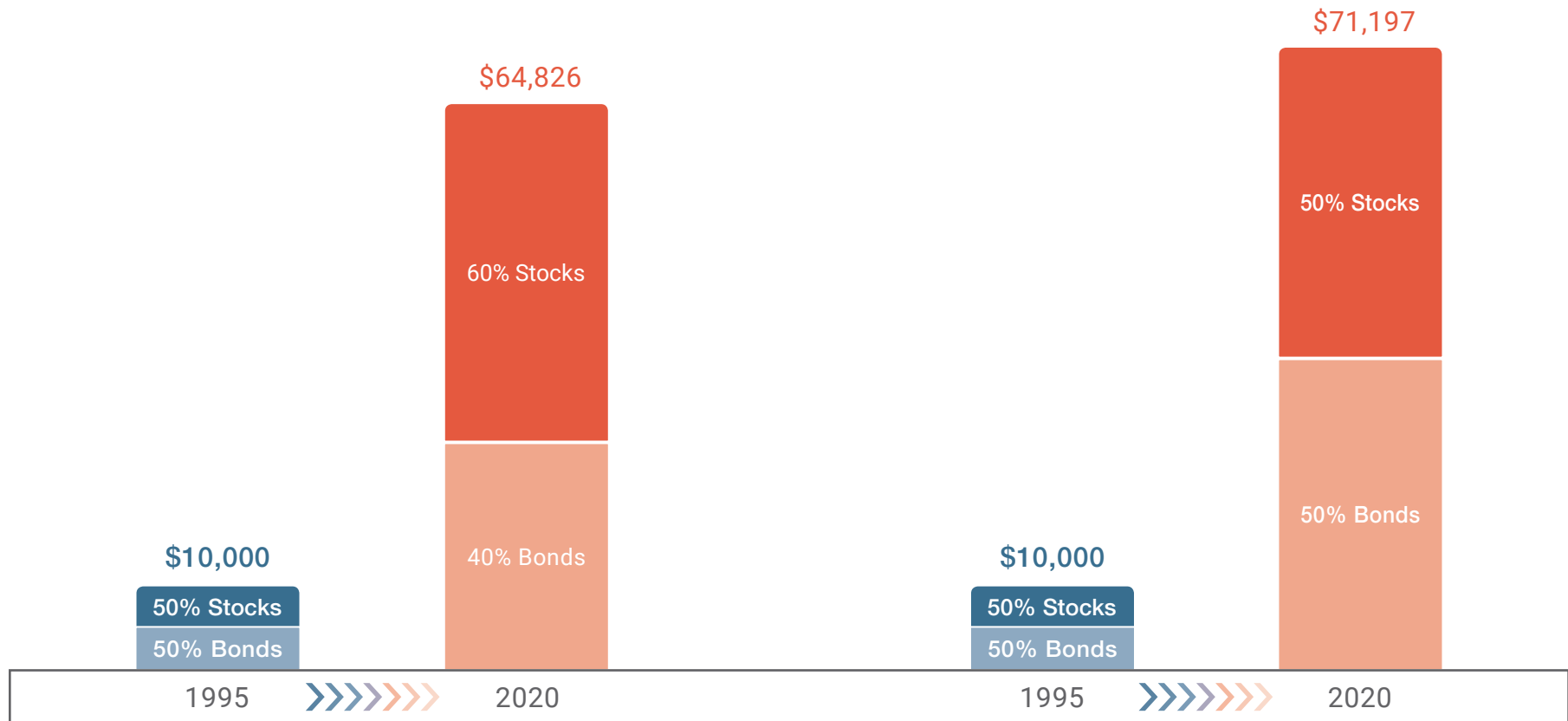


Rebalancing Act
